ADJUSTMENT TO THE EXCHANGE PRICE OF \$\$300,000,000 1.60% EXCHANGEABLE COLLATERALISED SECURITIES DUE 2019 OF RUBY ASSETS PTE. LTD.

Ascendas Funds Management (S) Limited, as manager of Ascendas Real Estate Investment Trust ("A-REIT", and as manager of A-REIT, the "Manager") refers to:

- (i) the S\$300,000,000 1.60% Exchangeable Collateralised Securities due 2019 (the "ECS") issued by Ruby Assets Pte. Ltd. (the "Issuer"), which are exchangeable into new units in A-REIT ("Exchange Units");
- (ii) the announcements dated 8 March 2013 in relation to the placement of new units in A-REIT ("New Units") to institutional and other investors (the "Private Placement") and the intention to declare a distribution of A-REIT's distributable income for the period from 1 January 2013 to 18 March 2013, being the day immediately prior to the date on which the New Units were issued pursuant to the Private Placement (the "Advanced Distribution");
- (iii) the announcement dated 15 April 2013 in relation to the actual quantum of the Advanced Distribution; and
- (iv) the announcement dated 15 April 2013 in relation to the distribution for the period from 19 March 2013 to 31 March 2013 (the "Relevant Distribution").

Unless otherwise defined, capitalised terms used in this announcement shall have the same meaning as defined in the terms and conditions of the ECS (the "Terms and Conditions").

The Terms and Conditions provide for adjustments to be made to the Exchange Price in the event an Excess Distribution is paid or made to A-REIT Unitholders. The Advanced Distribution and the Relevant Distribution would each result in an Excess Distribution. As the Advanced Distribution and the Relevant Distribution were announced within a short period of time, the

Manager will, pursuant to Condition 6.4(k) of the Terms and Conditions, make a one-time adjustment to the Exchange Price to reflect an Excess Distribution of \$\$0.0237 per unit in A-REIT.

The Manager is pleased to set out below, a summary of the adjustment to the Exchange Price based on the formula in Condition 6.3(c) of the Terms and Conditions:

Where:

Current Exchange Price = \$\$2.2392 per A-REIT Unit.

A = S\$2.6190, being the Current Market Price¹ per A-REIT Unit on the last Trading Day preceding 15 April 2013, the date on which the actual quantum of the Advanced Distribution and Relevant Distribution is

first publicly announced.

B = S\$0.0237, being the Fair Market Value of the Excess

Distribution attributable to one A-REIT Unit.

The Adjusted Exchange Price is therefore S\$2.2189.

In accordance with Condition 6.3(c) of the Terms and Conditions, the Adjusted Exchange Price will take effect on 27 May 2013, being the date on which the Relevant Distribution will be made to the A-REIT's Unitholders.
