

## **A-REIT completes divestment of Block 5006 Techplace II**

31 March 2014, Singapore – Further to the press release dated 24 August 2012, Ascendas Funds Management (S) Limited (the “**Manager**”), the manager of Ascendas Real Estate Investment Trust (“**A-REIT**”) is pleased to announce that the proposed divestment of Block 5006 Techplace II in Singapore (the “**Property**”) to Venture Corporation Limited (the “**Venture**”) for S\$38.0 million has been completed today.

The proforma impact on A-REIT’s net property income and distribution per unit for FY12/13 is approximately S\$1.48 million and 0.01 cents respectively, assuming that the divestment was completed on 1 April 2012.

The sale proceeds from this divestment may be used to repay existing indebtedness, or for A-REIT’s general corporate and working capital purposes and/or to distribute to Unitholders.

In accordance to A-REIT’s Trust Deed, the Manager is entitled to a divestment fee of 0.5% of the sale price of the Property.

### **About the Property**

Block 5006 Techplace II is one of the six blocks of flatted factory buildings at Techplace II located at Ang Mo Kio Avenue 5 and has a gross floor area of approximately 18,018 sqm. Venture is currently the largest tenant at Techplace II.
