PAYMENT OF BASE MANAGEMENT FEE BY WAY OF ISSUE OF UNITS IN ASCENDAS REAL ESTATE INVESTMENT TRUST

The Board of Directors of Ascendas Funds Management (S) Limited ("**AFM**") wishes to announce that 1,538,513 units ("**Units**") in Ascendas Real Estate Investment Trust ("**A-REIT**") have been issued to AFM, in its capacity as Manager of A-REIT. The Units allotted today at an issue price of S\$2.3396 per Unit were for the payment of 20% of the base management fee ("**Base Management Fee**") for the period from 1 December 2013 to 31 May 2014.

The Base Management Fee is calculated in accordance with the Trust Deed constituting A-REIT (the "**Trust Deed**") by taking 0.5% per annum of the value of adjusted deposited property¹ of A-REIT at the end of each month. In accordance with the Trust Deed, the Manager may elect from time to time to receive the Base Management Fee wholly in units or wholly in cash or in any combination of both. The Manager has elected to receive 20% of the Base Management Fee in Units and 80% in cash for all properties so as to align the interest of the Manager with the interests of the Unitholders of A-REIT.

The issue price was determined in accordance with the Trust Deed and is based on the volume weighted average traded price for all trades done on Singapore Exchange Securities Trading Limited ("**SGX-ST**") in the ordinary course of trading on the SGX-ST for 10 business days (i.e. from 2 June 2014 to 13 June 2014) immediately preceding the date of issue of Units to AFM.

Following the above issue of Units, the total A-REIT units on issue is 2,404,060,171 of which AFM's holding is 44,811,137 units or approximately 1.86%. Consequently, Ascendas Pte Ltd, through its wholly owned subsidiaries, Ascendas Land (Singapore) Pte Ltd and AFM, has an aggregate deemed interest of 412,715,137 units in A-REIT or approximately 17.17%.

¹ Adjusted deposited property is defined as total assets under management less derivative assets and investment properties under development.
