Tembusu is filing this notification to report a change in the percentage level of its deemed interest in the Listed Issuer from 20.19% to 19.72% due to the issue of 64,000,000 new Units on 11 August 2016 pursuant to Private Placement.

("ALS"), (2) Ascendas Funds Management (S) Limited ("AFM") and (3) an indirect subsidiary which is an investment fund managed by SeaTown Holdings International Pte. Ltd. ("SeaTown"), as described below.
