Temasek is filing this notification to report a change in the percentage level of its deemed interest from 20.46% to 19.89% due to the issue of 77,896,659 new Units on 15 August 2016 pursuant to the exchange of the ECS.

Temasek's deemed interest arises from the aggregation of interests held by (1) Ascendas Land (Singapore) Pte. Ltd. ("ALS"); (2) Ascendas Funds Management (S) Limited ("AFM"); (3) DBS Bank Ltd. ("DBS Bank"); (4) an indirect subsidiary which is an investment fund managed by SeaTown Holdings International Pte. Ltd. ("SeaTown"); (5) Dymon Asia Multi-Strategy Master Fund ("Dymon Fund") and (6) EM Services Pte Ltd ("EM Services").
