Temasek is filing this notification form to report a change in the percentage level of its deemed interest from 20.01% to 19.98% as a result of the disposal of 770,000 Units by DBS Bank on 3 October 2016.

Temasek's deemed interest arises from the aggregation of interests held by (1) Ascendas Land (Singapore) Pte. Ltd. ("ALS"); (2) Ascendas Funds Management (S) Limited ("AFM"); (3) DBS Bank Ltd. ("DBS Bank"); (4) an indirect subsidiary which is an investment fund managed by SeaTown Holdings International Pte. Ltd. ("SeaTown"); and (5) EM Services Pte Ltd ("EM Services").
