**ANNOUNCEMENT  
DISCLOSURE PURSUANT TO RULE 704 (31) OF THE LISTING MANUAL OF THE  
SINGAPORE EXCHANGE SECURITIES TRADING LIMITED**

The Board of Directors of Ascendas Funds Management (S) Limited, as manager (the “**Manager**”) of Ascendas Real Estate Investment Trust (“**Ascendas Reit**”), wishes to announce that:

- i) Ascendas US REIT LLC (the “**Borrower**”, being a wholly-owned subsidiary of Ascendas US Holdco Pte. Ltd., the shares of which were acquired<sup>1</sup> by Ascendas Reit) has secured a US\$200 million committed term loan facility maturing in 2023 (the “**US\$200m Facility**”); and
- ii) the Borrower has secured a US\$280 million committed term loan facility maturing in 2024 (the “**US\$280m Facility**” and together with the US\$200m Facility, the “**Facilities**”).

The obligations of the Borrower under the Facilities are guaranteed by HSBC Institutional Trust Services (Singapore) Limited (in its capacity as trustee of Ascendas Reit).

Pursuant to Rule 704(31) of the Listing Manual of the Singapore Exchange Securities Trading Limited (“**SGX-ST**”), the Manager wishes to announce that under the Facilities, it is an event of default if the Manager is removed and no replacement or substitute manager of Ascendas Reit is appointed in accordance with the terms of the trust deed constituting Ascendas Reit.

If such an event occurs and the Borrower fails to pay the outstanding amounts due and payable under either of the Facilities, it may trigger cross defaults under other facilities, debt issues and borrowings of Ascendas Reit and/or its subsidiaries (collectively, together with the amount owing under either of the Facilities, “**Borrowings**”). The aggregate level of Borrowings which are outstanding and that may be affected is approximately S\$4,656 million<sup>2</sup> (excluding interest) as of today. This has taken into account the reduction in Borrowings which are to be repaid using the Facilities.

As of the date of this Announcement, the event described above has not occurred.
