- (i) CLI FM Pte. Ltd. which in turn is deemed to have an interest in the units held by AFM;
- (ii) CLI International Pte. Ltd. which in turn is deemed to have an interest in the units held by CLI RE Fund Investments Pte. Ltd..

CLG is a subsidiary of CLA and therefore, CLA is deemed to have an interest in the units in which CLG has an interest by virtue of Section 4 of the Securities and Futures Act, Chapter 289 of Singapore.
